Annual Monitoring – NAPLEX

The ACPE Board of Directors reviews the policy regarding annual monitoring of NAPLEX scores on a regular basis. As you may recall, in January 2024, the Board acted to maintain ACPE's NAPLEX score benchmark of two standard deviations below the national average for first-time test takers. As outlined in the Policy, ACPE will continue to send letters requesting that programs identify the cause of negative changes or trends in NAPLEX® outcomes and request action plans for correcting the negative trends. At the recent June 2025 meeting, the Board approved an update to policy 11.6.1, Changes and Trends in NAPLEX Outcomes, which also identifies a bright line of 60% for NAPLEX pass rate in addition to the two standard deviation threshold. The change is as follows:

- 11.6.1 The program's NAPLEX pass rates among first-time test takers must equal or exceed ACPE's benchmark calculated as the national average minus two standard deviations OR 60% whichever is greater. Effective July 1, 2025, if the College/ School's pass rate for the NAPLEX examination falls below the national average, minus two standard deviations or 60% within a seven-year period, the following actions will be taken:
 - following the first occurrence, a letter will be sent to the program requiring that the program identify the root cause for the observed performance and provide an action plan for correcting the negative performance observed;
 - following the second occurrence, the Board will request a focused evaluation be completed to evaluate the program's compliance with the accreditation standards;
 - following the third occurrence, the program may be requested to meet with the ACPE Board of Directors to discuss steps taken to enhance NAPLEX performance;
 - 4) following the fourth occurrence, or as determined by the ACPE Board of Directors, the program may be placed on probation; and,
 - 5) following the fifth occurrence in a seven-year period, accreditation of the program may be withdrawn.

In addition, as of the June 2024 meeting, the Board started reviewing trends in the overall number of first-time test takers failing the NAPLEX examination at each program. A program is flagged if it has a high number of failures (defined as 30 or more first-time test takers not passing the exam), but still has an overall first-time passing rate above the threshold. This trigger could indicate potential problems regarding the quality of the professional degree program, the nature of which must be identified by the program.

Update on ACPE Fees

The ACPE Board of Directors will not be increasing fees for the Colleges and Schools, Continuing Pharmacy Education or International Services Programs in 2026. ACPE fees have only been increased once since 2020. ■



PharmD Program Accreditation / Colleges and Schools Division

All previously trained site team evaluators must complete the re-training webinar on Standards 2025 before going on site evaluations beginning fall 2025.

During summer 2025, site team members received instructions and requirements for completion in order to participate in visits. To accommodate requests to share this information with faculty who are not trained as ACPE site evaluators, ACPE is making this webinar available to the full Academy. The webinar and password can be found on the ACPE website under the PharmD Program Accreditation tab and selecting the Training and Workshops.

A webinar has been prepared and can be found on the ACPE website to familiarize site team members with the new self-study reporting system, PHARMS. All self-studies will be submitted through PHARMS and programs will not be required to send a flash drive to each team member. An additional webinar has been created to familiarize team members with the PHARMS website. The link and password can be found on the ACPE website under the PharmD Program Accreditation tab and selecting Training and Workshops.

ACPE Colleges and Schools Summer Workshops

ACPE hosted two Colleges and Schools training events in the conference facility within ACPE's office suite. ACPE staff hosted a self-study workshop for 59 deans, self-study chairs, and



faculty on July 23–24, 2025. The workshop assists programs in launching and conducting a continuous quality improvement process on compliance with ACPE's accreditation standards. ACPE offers this workshop annually for those programs beginning their self-study. ACPE staff also hosted a two-day evaluator training workshop for 30 participants on September 10–11, 2025. This workshop trains and prepares new site team members for participation as active reviewers during ACPE on-site evaluations of Doctor of Pharmacy programs.

This section of the newsletter provides insight into tools and technology available to ACPE constituents. The goal is to provide tools and tips to the user community as well as provide knowledge and direction on how to best use the technology available to us.

This issue's article will focus on the tips and tricks for the ACPE Pharmacy Accreditation Report Management System (PHARMS) that will be used to generate the Self-Study for the College/School accreditation process, which is currently available for the Fall 2025 cycle and going forward.

With the release of the new 2025 standards and corresponding rubric, the decision was made to develop an online platform, managed by ACPE, for colleges and schools to create, manage, and submit their program's self-study report via any common web browser.

The Pharmacy Accreditation Report Management System (PHARMS) for the Professional Degree Program of Colleges and Schools of Pharmacy is designed to assist a college or school in preparation of its self-study report and document how its program is addressing the ACPE standards. The platform specifically identifies the documents, data, and narrative text that should be provided by the college or school for evaluation of the program's compliance with each standard.

Below we will outline some key tips when assembling and submitting your narratives via the PHARMS system.

General Narrative Tips

- Narratives are required. You will not be able to submit your self-study to ACPE if you do not provide
 a narrative when asked to do so.
- Maximum character allowances differ per standard. You will find the character allowance in the
 narrative description. If you exceed the allowance, you will not be able to save the document until the
 content is reduced to the maximum allowable characters.
- You may cut and paste content from other sources. Images, tables, and graphs can be pasted into the narrative section. You may also create your narrative in another application (such as Microsoft Word) and then paste the content into the applicable narrative section.

Tips When Using MS Word (or other word processing programs)

- Use the same font and font size throughout. We suggest Arial font with a minimum font size of 12 pt.
 To improve readability further, a 14 pt font may be used. You may use larger fonts for section headers.
- Set your line spacing. We suggest using line spacing of at least 1.5 but recommend 2.0 for readability.
 Make sure this is applied throughout the word document.

- Set your Headers to be Header 3 (H3) and higher. If you want to use headers, set your highest-level
 header to be Header3 (H3) and then use Header 4 (H4) and Header 5 (H5) for subsections. This will allow
 the PDF report to automatically create bookmarks that can be used by the reviewer.
- Set table headers. Set your table headers to Repeat Header Rows. This will allow for table headers to span pages in a printed Program Self-Study PDF. The same can be applied to any table footers (Repeat Footer Rows) if desired.
- Adjust tables in the narrative text area. After pasting your content/tables into the narrative text area, stretch your tables such that they go across the width of the text area box in the specific standard to improve readability.
- Review and adjust your images. Make sure to review and adjust any images pasted into the narrative text
 area to reasonable sizes such that they are readable for the reviewer.
- Remove any page breaks rules. Remove any page break/keep together rules you may set for Headers, Paragraphs, Tables and/or Images. By having page break rules, the system may put breaks in unintended places thereby affecting the appearance of the report.
- You may include hyperlinks. The document may include hyperlinks to uploaded evidence where needed/ applicable. You may also hyperlink to publicly accessible content. Please do not hyperlink to content that is secure/password protected. Reviewers will not be able to view the content without the proper credentials.



CPE Updates/Accreditation Cycle Observations Spring 2025

Following each evaluation cycle, CPE staff review outcomes to identify best practices and common areas of non-compliance. This June, nearly 120 providers joined a virtual workshop where staff shared findings on the standards most often unmet. Attendees also had the chance to connect with one another-discussing shared compliance challenges, exchanging practical strategies and tools, and building peer networks for ongoing support and collaboration. The recording and presentation slides are available on our website for those who were unable to attend or would like to revisit the content. These efforts help strengthen compliance and promote consistent application of best practices across all providers.



Comprehensive Review findings revealed that Standards 1–5 were the areas most often cited for non-compliance:

Standard 1– Achievement of Mission and Goals

- · Goals are not specific and measurable
- Assessment plans are lacking or do not align with mission and goals
- Use of data analysis for ongoing improvement is not evident

Standard 2 - Gap Analysis

 Evidence of how gap analysis informed development of specific CPE activities is not evident

Standard 3 – CPE Activities and Standard 4 – CPE Learning Objectives

Learning objectives do not match activity type

Standard 5 - Standards for Integrity and Independence

 Providers had not updated to the current standards, as this was not evident in documentation. During the summer, staff worked with all providers to come into compliance with the Standards for Integrity and Independence.

Future of Continuing Pharmacy Education (CPE)

As our celebration of 50 years of ACPE CPE Provider Accreditation draws to a close, it is important to not only reflect on where we have been, but where CPE is going. Over the next 50 years, continuing pharmacy education will evolve alongside changes in pharmacy practice, regulations, and learner needs:

- Expanded Scope of Practice Pharmacists and pharmacy technicians will continue taking on more patient-care services (e.g., prescriptive authority, test-to-treat, tobacco cessation), requiring additional education to develop new knowledge and skills.
- Advanced Credentials As scope of practice expands, more states will enable
 pharmacists to obtain credentialing and reimbursement for patient-care services,
 making CPE critical for demonstrating competencies.
- Increasing & Complex CPE Requirements Regulatory expectations for re-licensure and enhanced service provision are becoming more detailed, with growing requirements for both hours, topics, and delivery formats (e.g., live sessions).
- Standard of Care Regulatory Model Some states are adopting a model that
 prioritizes practitioner competence over rigid CPE mandates, allowing pharmacists to
 provide more services as long as they demonstrate appropriate training and expertise.
- Continuing Professional Development (CPD) Integration CPE is shifting toward a
 personalized, goal-based learning approach, using the CPD framework to create
 individualized plans with evidence-based, practice-relevant education.

Overall, CPE will remain essential in equipping pharmacists and pharmacy technicians with the competencies needed to deliver high-quality, patient-centered care in an evolving healthcare landscape. We look forward to another 50 years of collaboration and innovation to advance continuing pharmacy education for our learners and the patients they serve.



Update on Quality Criteria

The ACPE International Commission and Board of Directors approved the release of the final version of the revised Quality Criteria for International-Accreditation of Professional Degree Programs in Pharmacy ("Criteria 2026") (Link: www.acpe-accredit.org/pdf/QualityCriteria2026Final.pdf).

The International Commission and Board considered all feedback received through online listening sessions and an online survey on the draft Criteria prior to approval of the final version. The effective date for implementation of Criteria 2026 is July 1, 2026, after which all programs holding international-accreditation status are expected to be in compliance with the expectations in the Criteria. A new rubric to support Quality Criteria 2026 has been released along with a crosswalk between the current (legacy) Quality Criteria and the Quality Criteria 2026. The documents can be found on ACPE's website. Along with the revised Quality Criteria, ACPE is in the process of developing an online platform for submission of the self-study report that serves as the basis for a comprehensive review.

ISP Programmatic Update — Summary of Changes/New Initiatives, etc.

To support ISP activities, ACPE is in the process of developing educational opportunities, including workshops and an educational series on curricular design, assessment, interprofessional education, and experiential education, including preceptor development. More details to come on these opportunities.
