

The Board approved the release of the draft of Standards 2025 for Doctor of Pharmacy Programs for comment at the January Board meeting. More information about the revision process can be found later in this newsletter (page 5).

Other topics discussed and actions taken at the January Board meeting include a change in annual monitoring, an update to the definition of an adverse action in ACPE policies, and several pieces of guidance from the continuing pharmacy education division.

### **Change in Annual Monitoring**

The ACPE Board of Directors authorized changes to the annual monitoring policy for professional degree programs, 11.6 (www.acpe-accredit.org/pdf/CSPoliciesandProcedures January2024.pdf).

Starting in June 2024, the Board will begin looking at trends in the overall number of first-time test takers failing the NAPLEX examination at each program.

#### Message from the Executive Director continued

Following analysis of ACPE's process for monitoring NAPLEX® outcomes, the Board has acted to maintain ACPE's Benchmark of two standard deviations below the national average for first-time test takers. As outlined in the Policy, ACPE will continue to send letters requesting that programs identify the cause of negative changes or trends in NAPLEX® outcomes and provide action plans for correcting the changes or trends. Starting in June 2024, the Board will begin looking at trends in the overall number of first-time test takers failing the NAPLEX examination at each program. Programs with a large number of failures, yet still having an overall passing rate above the two standard deviations threshold, may be asked to identify the causes of such failures and provide action plans for reducing the number of first-time test takers failing the examination.

Beginning in July 2025, with the release of Standards 2025, the Board has approved actions to be taken based on the number of times a program falls below the two standard deviations (2SD) benchmark.

The specifics of the policy are as follows:

Within any seven-year period:

- 1st year passing rate below 2SD: letter sent requiring root cause analysis for poor performance and action plan for improvement
- 2nd year passing rate below 2SD: focused on-site evaluation to explore the program's compliance with accreditation standards
- 3rd year passing rate below 2SD: program requested to meet with ACPE Board of Directors
- 4th year passing rate below 2SD: program subject to probationary action
- 5th year passing rate below 2SD: program subject to withdrawal of accreditation

In addition, as part of ACPE's On-Time Graduation Rate Monitoring policy, programs exceeding ACPE's benchmark of 24% attrition of the matriculating class size will be requested to provide an update on the status of students with delayed graduation.

### **Adverse Action Definition**

The ACPE Board of Directors approved an update to Section 13 of the Policies and Procedures to modify the definition of an adverse action. To align with USDE policy, Accredited with Probation is no longer considered an adverse action, which removes the opportunity for appeal. ### **Continuing Pharmacy Education**

The January 2024 ACPE Board of Directors and CPE Commission approved guidance for ACPE-accredited CPE providers in the areas of diversity, equity and inclusion, artificial intelligence, digital badges and certificate programs. ### 2023 NAPLEX Scores

### Council for Higher Education Accreditation (CHEA)

At the January 29, 2024 meeting, the Council for Higher Education Accreditation (CHEA) Board of Directors reviewed the recommendation of the CHEA Committee on Recognition regarding the application for continued CHEA recognition of the American Council for Pharmacy Education (ACPE). The CHEA Board of Directors accepted the Committee's recommendation and granted recognition to ACPE for the maximum term of seven years.

The ACPE staff currently have a very heavy travel schedule for spring 2024. They continue to complete all comprehensive evaluations live and on-site. Where appropriate, they will continue to conduct focused evaluation visits virtually. All international site visits for the spring cycle have been completed successfully on-site or virtually when travel was not possible.

Greg Boyer was a panelist presenting ACPE's approach to annual monitoring at the Annual Meeting of CHEA, on January 31, 2024, in Washington DC. Convened by the Association of Specialized and Programmatic Accreditors (ASPA), the panel members spoke on the topic of data collection and ensuring compliance with accreditation standards. Representatives from the Council on Social Work Education and the National Accrediting Agency for Clinical Laboratory Sciences joined Greg in this discussion.

ACPE Continuing Pharmacy Education (CPE) staff have been busy giving presentations both at meetings and via virtual webinars for various audiences.

# Draft Standards 2025

### **Attention Colleagues:**

The ACPE Board of Directors has approved a draft of the next revision of the Accreditation Standards and Key Elements for the Professional Program in Pharmacy Leading to the Doctor of Pharmacy Degree ("Draft Standards 2025") along with a draft of the Self-Assessment Instrument for the Professional Degree Program of Colleges and Schools of Pharmacy (i.e., rubric) for Standards 2025. The ACPE Board has authorized a period of comment on the draft standards to begin January 26, 2024 and conclude May 15, 2024. All comments and feedback will be reviewed before finalizing the documents. The ACPE Board will release the final version of the new standards in June 2024 with implementation on July 1, 2025. At its January 2024 meeting, the ACPE Board authorized the release of a draft version of Standards 2025 and established a period of public comment on the draft for the spring 2024 cycle. A town hall was led by ACPE's Executive Director with the Joint Commission of Pharmacy Practitioners (JCPP) the day after the draft standards were released. Numerous other town halls were scheduled during the spring 2024 cycle to obtain as much feedback from the profession as possible. The town halls include representatives from many pharmacy organizations representing a broad array of practice sites, specialties and preceptors.

After review of all comments received before the deadline prior to its June 13–16, 2024, meeting, the ACPE Board plans to finalize and release Standards 2025 at the June 2024 meeting, with full implementation by July 1, 2025. Prior to that date, all comprehensive evaluations will be conducted against Standards 2016.

This section of the newsletter provides insight into tools and technology available to ACPE constituents. The goal is to provide tools and tips to the user community as well as provide knowledge and direction on how to best use the technology available to us.

This issue's article will focus on the newly developed self-study reporting system, PHARMS-PHarmacy Accreditation Report Management System, that will be used to generate the self-study for the College/School accreditation process starting in July 2025.

At the January 2024 meeting, the ACPE Board of Directors approved releasing a draft of Standards 2025 and the corresponding self-study rubric. With the planned release of the new standards and the corresponding rubric for 2025, the decision was made to create an online platform, managed by ACPE, for colleges and schools to create, manage and submit their program's self-study report via any common web browser.

The Pharmacy Accreditation Report Management System (PHARMS) for the Professional Degree Program of Colleges and Schools of Pharmacy is designed to assist college or school of pharmacy staff to prepare its self-study report and document how its pharmacy degree


**ACPE Pharmacy Accreditation Report Management System (PHARMS)** 

program is addressing ACPE's Standards. The platform specifically identifies the documents, data and narrative text that should be provided by the college or school for evaluation of the program's compliance with each of the Standards.

The process works as follows:

- College or school staff will be added to PHARMS. Each user will have an account created using an email address as the username.
- When your program is scheduled for a Comprehensive Review, the individual(s) granted access will receive an email from ACPE indicating that the platform is ready for the self-study to be entered.
- · The college or school staff will then be able to access the self-study platform via a web browser and begin the process of writing the self-study, evaluating the program, submitting evidence, and providing a narrative.
- · Please note: ACPE and evaluation team members will NOT have access to the self-study content UNTIL the college and school staff has completed every section of the rubric, all required evidence has been provided, all narratives have been entered, AND the college or school has attested to the completeness and accuracy of the information provided.







The document can be prepared as a Word® document that can be copied and pasted into the platform once access is granted. An editor that allows for manual formatting of your content within the platform is included.

A sample narrative of Standard 1 appears below:



The college or school will determine their overall compliance level with the standard as well as provide recommended monitoring if they do not rate the standard as compliant.



After the self-study has been completed, the college or school will be required to attest that the document is ready for review by ACPE. The attestation process will trigger an email to ACPE and allow both staff and evaluators to access the self-study.



Future plans for the platform include additional reports, i.e., focused visits and interim reports, being submitted through PHARMS. This system will also be used by the evaluation team to perform the evaluation, document findings, and ultimately generate both an Evaluation Team Report (ETR) and Action and Recommendations (A&R) document.

More information will be provided in the upcoming months regarding the platform. Platform training will be provided as part of the ACPE Self-Study Workshop occurring later this year. Any questions can be directed to csinfo@acpe-accredit.org.

# Three ACPE-accredited CPE Providers Earn Accreditation with Commendation:

Providers must demonstrate compliance with all Standards for Continuing Pharmacy Education, Policies, and Procedures and two commendation criteria in two subcategories of their choice to earn Commendation status. Commendation is noted on ACPE's website in the CPE Provider Directory. There are seven ACPE-accredited providers with Commendation status.

# **Certificate Programs**

ACPE requires that ACPE-accredited providers use the term 'Certificate Program' for CE activities that comply with the ACPE-defined Certificate Programs. ACPE-accredited providers who use the term Certificate Program for activities that do not meet the expectations for Certificate Programs as defined in the ACPE Standards and Policies must include a disclaimer: 'This is not an ACPE-defined Certificate Program; learners who complete this course will receive ACPE CPE credit but will not be awarded completion of a Certificate Program'.

Certificate Program activities are primarily constructed to instill, expand, or enhance practice competencies through the systematic achievement of specified knowledge, skills, attitudes, and performance behaviors. The information within the certificate program must be based on evidence as accepted in the literature by the healthcare professions. The formats of these CPE activities should include a didactic component (live and/or home study) and a practice experience component (designed to evaluate the skill or application). The provider should employ an instructional design that is rationally sequenced, curricular-based, and supportive of achievement of the stated professional competencies. The minimum amount of credit for these activities is eight contact hours.

# Diversity, Equity, and Inclusion Initiatives in Continuing Pharmacy Education

In January of 2024, the ACPE Board of Directors approved updated diversity, equity, and inclusion (DEI) guidance for CPE providers. The updated guidance was based on survey responses from ACPE-accredited CPE providers and a review of existing literature focused on DEI in health professions education. Entitled "ACPE Guidance to ACPE-accredited CE Providers to Incorporate Diversity, Equity, and Inclusion within Organizations and CE Activities," (www. acpe-accredit.org/pdf/Word%20Documents/DEI%20Guidance.pdf) the updated guidance focuses on approaches to fostering DEI at the organizational and activity level. The guidance provides a summary of best practices submitted by CPE providers and provides specific questions related to DEI which can be considered when planning, delivering, and assessing CPE activities.



Additionally, a manuscript highlighting survey responses and identified DEI best practices as reported by ACPE-accredited CPE providers is under peer review with the Journal of Continuing Education in the Health Professions (JCEHP).

### **Artificial Intelligence Guidance**

Artificial Intelligence (AI) has become very prominent in the world of education. ACPE staff explores the impact of AI on continuing education activities. To identify the factors and experience of ACPE-accredited CE providers, ACPE staff distributed a survey to identify the impact of AI on continuing education programs. Results of the survey, a review of the literature, and discussion at the CPE Commission and the Board of Directors resulted in guidance for ACPE-accredited providers.

Providers are encouraged to include guidance related to AI in their faculty guidance materials. This guidance may include the following:

- If faculty use AI in the development of educational content for a CE activity, it is strongly suggested to disclose:
  - · The name of the AI application.
  - · The purpose for which the faculty used the AI application.
  - · The version of the Al application.
  - · The date the AI application was used.
  - This information should be disclosed to learners.

# State-specific CE Requirements and Pharmacy Scope-of-Practice

ACPE continues to play an important role in assuring quality education to meet state-specific continuing education requirements and support pharmacists in the provision of enhanced services. State-specific requirements for re-licensure have increased in specificity and complexity, with additional requirements extending into specific topic areas like implicit bias, drug therapy management, and human trafficking.

ACPE has continued to support CPE providers in assuring the most appropriate use of topic designators and has developed a process for providers to identify specific state requirements activities are intended to meet. Additionally, as pharmacists' scope-of-practice continues to change, CPE activities provided by ACPE-accredited CPE providers have continued to play an important role in obtaining the required training to provide additional services. To meet State Board of Pharmacy requirements for the provision of patient-care services, pharmacists are often required to complete activities developed by ACPE-accredited providers. As an example, states like Oregon require the completion of "Board-approved Accreditation Council for Pharmacy Education (ACPE) accredited educational training program(s)" prior to engaging in hormonal contraceptive prescribing.

In 2023, several laws were passed increasing pharmacist and pharmacy technician scope-of-practice and ability to bill state Medicaid programs for the provision of pharmacy services.

ACPE continues to support the development of CPE activities designed to help pharmacists develop confidence and competence in the provision of services which align with increased scope-of-practice and state-specific re-licensure requirements.


# Pharmacy Technicians Search for CE for Pharmacy Technician Certification Board (PTCB) Recertification

# **ACPE Continuing Professional Development** (CPD) Accreditation Program is Open!

In January 2024, ACPE launched the new accreditation pathway for providers of Continuing Professional Development (CPD) programs. ACPE defines CPD as "a self-directed, ongoing, systematic, and outcomes-focused approach to lifelong learning that is applied into practice." The new accreditation pathway creates the opportunity for providers to award learners with CPD units (CPDUs) for the completion of activities reflective of CPD cycle components (Reflect, Plan, Learn, Evaluate, and Apply).

To support providers interested in offering an accredited CPD program, ACPE staff and the CPD Advisory Committee have created educational resources and application materials which are available on the ACPE website. Additionally, ACPE staff have collaborated with pharmacy educators to create the CPD Case Study Series, which are educational webinars introducing the CPD concept and exhibiting how CPD can be used in a variety of educational settings. The first case study is now available, where Dr. Kelsey Frederick, Dr. Janet Cooley, and Dr. Suzanne Larson show how the CPD process can be used to create an APPE experience designed to facilitate lifelong learning.

Providers with and without an ACPE-accredited CPE program are eligible to submit CPD programs for consideration. Submissions are accepted now! 


# **Faculty Development Workshop**

### Spring 2024 evaluation visits:

Staff are currently conducting a SWOT analysis to determine the strengths, weaknesses, opportunities, and threats of the program with members of the International Commission. The goal is to define next steps for the program as it continues to grow. We will also be reaching out to our accredited programs and others for additional feedback.

The ACPE Staff and the International Commission are continuing their work on the revision of the Quality Criteria. There will be additional work done on the revision at the May 2024 International Commission Meeting.
