Latest updates from ACPE's June 2021 Board Meeting

Policy Updates

Addition to Policy 5 Continuing Education Credit

- *Live Activities* – Faculty may claim credit as a participant for their own presentations for the amount of credit offered for that activity. CPE Administrators may claim credit at sessions they attend as a participant at a live activity.
- *Home Study Activities* – Faculty may claim credit as a participant for their own activities for the amount of credit offered for that activity. CPE Administrators may claim credit for home study activities they complete as a participant.

Comprehensive Review Video Conference Call

Beginning with Fall 2021 comprehensive review calls will follow the following agenda:

- *Team conference* (time allotted for the review team to discuss the provider materials: 60 minutes.
- *Provider conference* (time allotted for review team to discuss provider's CPE program): 60 minutes.
- *Team Report* (review team finalizes report): 15 minutes.

Commendation Updates



During ACPE's Spring Evaluation Cycle, five ACPE-accredited providers submitted for Accreditation with Commendation.

- Timeline was modified. Providers submit for Comprehensive Review evaluation every 6 years. If the accreditation term results in a 6-year term with no additional reporting then the provider has the option to submit for evaluation for Commendation within 1 year (subsequent 2 cycles).

Request for ACPE CPE Commissioners

ACPE is requesting volunteers for three vacancies on the ACPE Continuing Pharmacy Education Commission (CPEC) from Academia,

settings. The duties of the CPEC include:

- recommending policies and procedures for the ACPE Continuing Pharmacy Education Provider Accreditation program;
- assist in strategic planning;
- contribute in planning of ACPE's educational activities;
- review ACPE-accredited provider's comprehensive reports, progress reports; and,
- recommend accreditation actions to the ACPE Board of Directors.



The term of a CPE Commissioner is 3 years (January 2022 - December 2024) with an opportunity to serve additional term(s). Each CPEC member shall have experience in continuing and/or adult education and awareness of contemporary pharmacy education and practice. The CPEC meets two times per year (May, November) for three days at the ACPE office in Chicago (currently CPEC is virtual).
