ASHP AND ACPE ANNOUNCE NEW COMMISSIONERS FOR THE PHARMACY TECHNICIAN ACCREDITATION COMMISSION

BETHESDA, MD—The American Society of Health-System Pharmacists (ASHP) and the Accreditation Council for Pharmacy Education (ACPE) are pleased to announce the inaugural Commissioners for the Pharmacy Technician Accreditation Commission (PTAC). PTAC is tasked with promoting, assuring, and advancing the quality of pharmacy technician education and training programs in the United States. Beginning in the fall of 2014, PTAC will advise the ASHP and ACPE Boards on measures to ensure standardized quality pharmacy technician education and training programs. The ASHP and ACPE Boards will agree on the final accreditation actions. Appointed Commissions include:



Angela Cassano, PharmD, BCPS, FASHP is President of Pharmfusion

Consulting, LLC in Midlothian, Virginia, where the integration of pharmacy
technicians into pharmacy practice models is a focus. She facilitated the
2011 Pharmacy Technician Certification Board (PTCB) C.R.E.S.T. Summit
focused on the areas of consumer awareness, resources, education, state
policy and testing for pharmacy technicians. Dr. Cassano assisted in drafting

the pharmacy technician scope of practice document for the Virginia Pharmacy Congress and is the content expert for the ASHP Pharmacy Technician CE portal. Dr. Cassano will serve as a PTAC Commissioner through 2017. Michael Diamond, MSc is President of World Resources Chicago in Evanston, Illinois, where his primary focus is to improve health outcomes in resource challenged communities. For more than 30 years, he worked with global health, refugee, rehabilitation, and social and economic development programs in over 100 countries. He is also a Visiting Assistant Professor at DePaul University School of Public Service



and lectures on global health, management of civil society organizations, and the reduction of health disparities at Northwestern University. Diamond previously served on ACPE's Public Interest Panel. He will serve a two-year term on the Commission.



Jacqueline Hall, RPh, MBA is a Pharmacy Manager with Walgreens, the Director of Pharmacy services for St. Vincent de Paul Community Pharmacy, and an Adjunct Clinical Assistant Professor in Xavier University College of Pharmacy in New Orleans, Louisiana. She served as a National Association of Boards of Pharmacy (NABP) Task Force Member on Standardized Pharmacy Technician Education and Training. Hall is also a member of the Louisiana

Board of Pharmacy. She will serve on PTAC through 2015.

Jan Keresztes, PharmD is the Pharmacy Technician Program Coordinator and Instructor at

South Suburban College in South Holland, Illinois. For over 20 years, Keresztes was a consultant editor to the *Journal of Pharmacy Technology* and worked with the American Association of Colleges of Pharmacy's Professional Affairs Committee to review their stance on pharmacy technician education and training. She co-founded the Pharmacy Technician Educators Council (PTEC) and served as its second



president. Dr. Keresztes was also a member of the first PTCB Council and will serve as a PTAC Commissioner through 2016.



Barbara Lacher, BS, RPhTech, CPhT is the Assistant Program Director and an Associate Professor of the Pharmacy Technician Program at North Dakota State College of Science in Wahpeton, North Dakota. She is the founding member of the Northland Association of Pharmacy Technicians, a member of PTEC, and was a member of ASHP's Pharmacy Technician and Support

Services committee. Lacher served on the Editorial Advisory Board for *Tech Teaching Tips* and has volunteered as a surveyor with ASHP. She will serve on the Commission through 2017.

Douglas Scribner, CPhT, MEd is the Program Director for pharmacy technology at Central New Mexico Community College in Albuquerque, New Mexico. He served on the PTCB advisory

board during the initial development of the certification exam. He also served as a member and chair of the ASHP Pharmacy Technician Advisory Group (PTAG). Scribner served as president of the New Mexico State Association of Pharmacy Technicians and the American Association of Pharmacy Technicians (AAPT) and was the first technician member of United States Pharmacopeia (USP). He will serve as a Commissioner through 2015.



John Smith, Ed.D. is the Assistant Vice President, Academic Affairs for Corinthian Colleges, Inc.



in Santa Ana, California where he is responsible for all Programmatic
Accreditation of programs in the U.S. and Canada. He served as a member
of PTAG and currently serves as an ASHP accreditation surveyor of
pharmacy technician training programs. Dr. Smith has held several
leadership positions for the California Society of Health-System

Pharmacists. He will serve a 2-year term on the Commission.

Donna Wall, PharmD has worked as a clinical pharmacist, PGY-1
Residency Director, and P&T secretary and drug information director at Indiana University Hospital in Indianapolis, Indiana, as well as an adjunct associate professor of clinical pharmacy at Purdue and Butler Universities. She is currently a member of Indiana's Board of Pharmacy. Dr. Wall served as the Vice President of ACPE's Board of Directors and was President of the NABP Board. She will serve on the Commission through 2015.





LiAnne (Webster) Brown, CPhT is an adjunct faculty member at Richland College in Dallas, Texas, and the administrator of Pharmacy Technology Certificate Programs. She is a technician educator and the author of *Pharmacy Practice Today for the Pharmacy Technician*. Brown served as an ASHP site surveyor, has experience as a technician and technician

supervisor, served on a task force for the Texas State Board of Pharmacy, and contributed expertise to PTCB's national scope of practice analysis. She will serve a 3-year term on PTAC.

The Boards of ASHP and ACPE have also appointed Board Liaisons to PTAC. **Anthony Provenzano, PharmD** will serve as ACPE's Board Liaison. Dr. Provenzano serves as Director of Clinical Services for New Albertson's, Inc., where he is responsible for the execution, quality, and profitability of all clinical services provided within the organization's community pharmacies. The ASHP Board of Directors has appointed **Kelly Smith, PharmD** to serve as their Board Liaison. Dr. Smith is Assistant Dean, Academic and Student Affairs and Associate Professor of Pharmacy Practice and Science for the University of Kentucky College of Pharmacy.
