



Meet the New ACPE Executive Director: Jan Engle, PharmD, PhD (Hon), FAPhA, FCCP, FNAP

At the end of August 2019, Dr. Peter Vlasses retired from his position at ACPE leaving very big shoes to fill. The new Executive Director, Jan Engle, began her position in September. Dr. Engle comes to ACPE after a long career in academia. She served in many positions at her prior institution, including as chair of the Department of Pharmacy Practice and executive associate dean. Early in her career, Dr. Engle established clinical pharmacy services at a Chicago-area Veterans Affairs hospital as well as initiated, directed, and received accreditation for the first pharmacy residency program at that institution.

Dr. Engle has been very involved in pharmacy leadership. She is past president of the American Pharmacists Association, the national professional society of pharmacists. Dr. Engle has served APhA in many other capacities including nine years on the APhA Board of Trustees and as president of the APhA Academy of Pharmacy Practice and Management.

Dr. Engle served as a voting member of the FDA Nonprescription Drug Advisory Committee and continues as a Special Government Employee Consultant to FDA. Dr. Engle is a past member of the Board of Pharmacy Specialties Board of Directors. She has also served on numerous committees for the American Association of Colleges of Pharmacy. Dr. Engle chaired several committees for the American College of Clinical Pharmacy and was the lead author on several commentary and white papers. Dr. Engle was elected as a distinguished practitioner and fellow in the National Academies of Practice in Pharmacy. She was also named a fellow of the APhA Academy of Pharmacy Practice and Management and a fellow of the American College of Clinical Pharmacy. Dr. Engle received the APhA Distinguished Achievement Award for Clinical/Pharmacotherapeutic Practice and the APhA Immunization Awareness Champion Award for Community Outreach for immunization awareness work she coordinated at her prior institution.

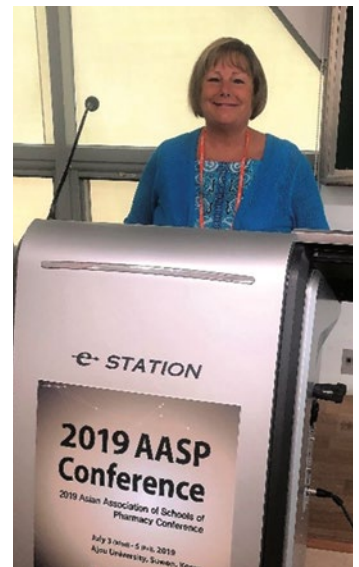

Dr. Engle is an internationally recognized expert on the topics of nonprescription medicines, pharmacy education, and leadership, and is very active in international pharmacy. She previously served as chair of the ACPE International Commission and is completing a third term as overseas expert of the Post Graduate Allied Health Institute Board at Singapore General Hospital. Dr. Engle has worked with National Taiwan University and was a guest professor at Harbin Medical University in China. She has worked for many years with the US–Thai Consortium on Pharmacy Education. Dr. Engle also worked with the Pharmacy Council of Thailand and received an honorary Doctorate in Pharmaceutical Sciences from Khon Kaen University in Thailand for her efforts. She served as a consultant to the Western Pacific Region of the World Health Organization. Dr. Engle remains active in the International Pharmaceutical Federation serving as the ACPE delegate to the FIP Council.

Dr. Engle is a frequently featured media expert. She has made many television appearances, including on “The Oprah Winfrey Show,” “Dr. Oz,” “World News Tonight with Peter Jennings,” “Fox and Friends Weekend,” Chicagoland TV, WBBM-TV, ABC7-TV, and WMAQ-TV — just to name a few. She has also conducted many media briefing sessions and been featured as a medical expert in numerous regional and national print publications including the Washington Post, New York Times, USA Today, Wall Street Journal, LA Times, Chicago Tribune, Cosmopolitan, Crain’s Chicago Business, Men’s Health, Parade, Prevention, Reader’s Digest, Shape, and many others.

From the Executive Director's Desk ...

Jan Engle, PharmD, PhD (Hon), FAPhA, FCCP, FNAP

As I write this, I have been at ACPE for six months. When I started my position at ACPE, I was very excited. I knew there would be a steep learning curve but never imagined that our profession would be dealing with a worldwide pandemic just a few short months later. Some very difficult decisions have been made during this time, including gearing up to deal with the issues created in pharmacy education by the novel coronavirus. COVID-19 has impacted every activity that ACPE handles and forced us to ask challenging questions. How do we, if at all, conduct site visits including domestic, international, and in partnership with ASHP, technician programs? How do we assure that our site teams, who were out in the field while this situation was beginning, are safe and able to get home — including those who were working internationally as airports were closing on a moment's notice? How do we assist schools facing the challenges of closed campuses and dwindling experiential education sites? These questions are just a small snapshot of the issues we needed to engage with and thoughtfully address.

I am happy to say that the ACPE staff, with their collective experience and wisdom, have been working hard to provide the best advice and support that we can to our constituencies. Our colleagues at AACP, NABP, APhA, and ASHP have also been very helpful in providing support. I never dreamed ACPE would be faced with these sorts of issues when I took this position, but have been so encouraged by the leaders in our profession who are stepping up to try and make the best decisions we can during these unprecedented times.

As I look into the future, I have several goals. First and foremost, ACPE needs to be above reproach for its accreditation and certification activities as well as to ensure excellence in all aspects of pharmacy education. This includes continuing our recognition by the U.S. Department of Education and the Council for Higher Education Accreditation. Next, I am in the process of fact-finding and listening. I have engaged our board members, staff, and internal as well as external constituencies in conversations to determine the opportunities and challenges ACPE faces. These dialogues included listening sessions at two national meetings,



the ASHP Midyear Clinical Meeting and the AACP Interim Meeting. We had to postpone our listening session at the APhA Annual meeting due to the cancellation of that meeting, but I hope to engage with them at a later date. I also hope to connect with other national pharmacy associations when meetings and travel are once again viable options. Furthermore, I have met with the leadership at NABP, ASHP, APhA, FIP and AFPE as well as the leadership of various accrediting bodies. Later this summer, we have three sessions planned to meet with leaders in experiential education, assessment, and curriculum to obtain feedback on various aspects of the self-study rubric and other areas relevant to ACPE.

Additional objectives will be discovered through strategic planning. Late this spring, members of our constituencies will receive surveys whose responses will inform our strategic planning process. I look forward to getting as much input as possible in order to inform ACPE staff and board considerations for ACPE strategic directions.

Furthermore, I aspire to build a culture of communication and transparency both within in and outside of the organization. As I have said to our staff and board, I cannot fix what I do not know about. I hope that all of you will feel comfortable reaching out and sharing your opinions.

Finally, I would like to express my thanks to my predecessor, Dr. Peter Vlases, who has been extremely helpful and willing to share his knowledge. I have very big shoes to fill, but Pete's advice and support have been very valuable. I am very thankful to the ACPE Board of Directors who gave me this opportunity. I look forward to working with all of the constituencies that ACPE serves. ■

ACPE Announces New Members of the Board of Directors

PharmD Program Accreditation

Spring 2020 On-Site Evaluations

The spring 2020 site visit schedule was developed with 26 visits between February 24 and May 8. Due to the COVID-19 pandemic, six visits were completed by March 12, 2020. If restrictions are lifted, three visits will be completed in June 2020 for programs with time sensitive matters. All other visits (17 onsite evaluations) have been shifted to the fall 2020 schedule and will be added to the 11 visits scheduled for that cycle. The ACPE Board of Directors will be approving term extensions until January 31, 2021, to allow for each of the 17 postponed on-site evaluations to be completed in fall 2020. Thus, there will not be disruption in any program's current accreditation status.

In the upcoming months, ACPE will be filling site visit teams for all 26 on-site evaluations now planned for fall 2020. For those trained program evaluators, your timely response to the call of reviewers will be most appreciated. We cannot do our work without you.

We also appreciate the thoughtful comments and questions we've received during the COVID-19 pandemic. This situation has impacted all of us in profound ways. By working with many of you, additional ways to achieve the expectations of the ACPE accreditation standards have been developed. While some may be temporary, some could be carried on to more normal times. ACPE appreciates the understanding we must have to live within the boundaries of the standards as we all strive to provide quality pharmacy education. ■

2020 Self-Study Workshop Schedule

ACPE staff will once again offer the popular Self-Study Workshop over **two August 2020 dates in Chicago**. This workshop is designed over two half-days, afternoon of the first day and morning of the second day, requiring only one night in Chicago — unless you decide to schedule some vacation time in ACPE's exciting city! Deans and/or self-study chairs can choose to attend Tuesday and Wednesday, August 4–5 or Thursday and Friday, August 20–21. The Self-Study Workshop is interactive, with ACPE staff providing guidance on best-practices and programs sharing their learnings from past self-study experiences as well as upcoming plans.

The Self-Study Workshop is a great way to launch self-study and network with colleagues doing the same. Registration is limited to three individuals from a given College or School of Pharmacy, and registration is capped at 30 people total per workshop. Programs with comprehensive reviews within the next 24 months are encouraged to attend. The workshop registration fee is \$575 per person, which includes two lunches, one on-site breakfast, and one dinner at a Chicago Loop restaurant. Continuing Education Provider Accreditation

ACPE CPE Commendation Criteria for ACPE-accredited Providers

Receiving ACPE accredited status provides recognition that a provider meets minimum expectations towards the provision of quality continuing education. Within ACPE's continuing pharmacy education accreditation process, providers must demonstrate compliance with 11 standards representing four sections: content, delivery, learning assessment, and evaluation. Beginning January 1, 2021, accredited CPE providers have the option to demonstrate that they surpass the minimum requirements of accreditation by pursuing commendation. It is ACPE's expectations that providers pursuing commendation will outline within their mission and vision the desire to advance practice, knowledge, and skills of learners as well as the profession. ACPE aims to encourage and reward accredited CPE providers for implementing best practices in pedagogy and assessment as well as for focusing on generating meaningful outcomes for learners.

ACPE utilizes a menu approach for recognition of Accreditation with Commendation in an effort to promote flexibility, reflect the diversity of accredited providers, and offer a pathway for all providers to pursue Accreditation with Commendation. The menu of criteria for Accreditation with Commendation can be used by any ACPE-accredited provider applying for Accreditation with Commendation. The commendation criteria, rubric, and process for commendation will be distributed soon.

Highlights from the 2019 report include:

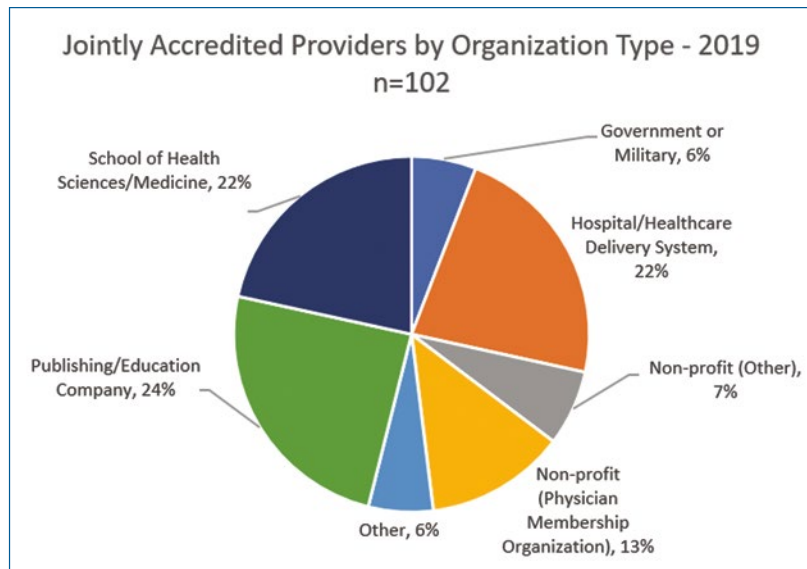

User Feedback on the My CPD Platform

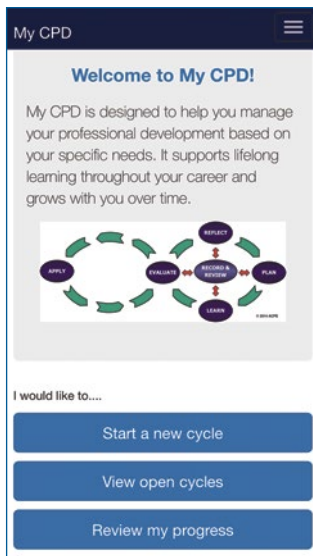
Continuing Professional Development is a self-directed, ongoing, systematic, and outcomes-focused approach to lifelong learning that is applied into practice. It involves active participation in formal and informal learning activities that assist in developing and maintaining competence, enhancing professional practice, and supporting achievement of career goals. The focus of CPD is on the results — the real world benefits of learning and development.

In 2018 the National Association of Boards of Pharmacy® launched CPE Monitor Plus, a subscription service that provides access to expanded features. Developed in partnership with ACPE, the upgraded features of CPE Monitor Plus support pharmacists with tracking continuing pharmacy education requirements and deadlines necessary to maintain their licenses. It also enables licensees to upload and apply non-ACPE-accredited continuing education credits and certificates to relevant state licenses, receive notifications when CE cycle deadlines are approaching, generate reports of CE activity using a custom data range or the current CE cycle of the relevant license, and provides access to ACPE’s CPD Platform, My CPD.

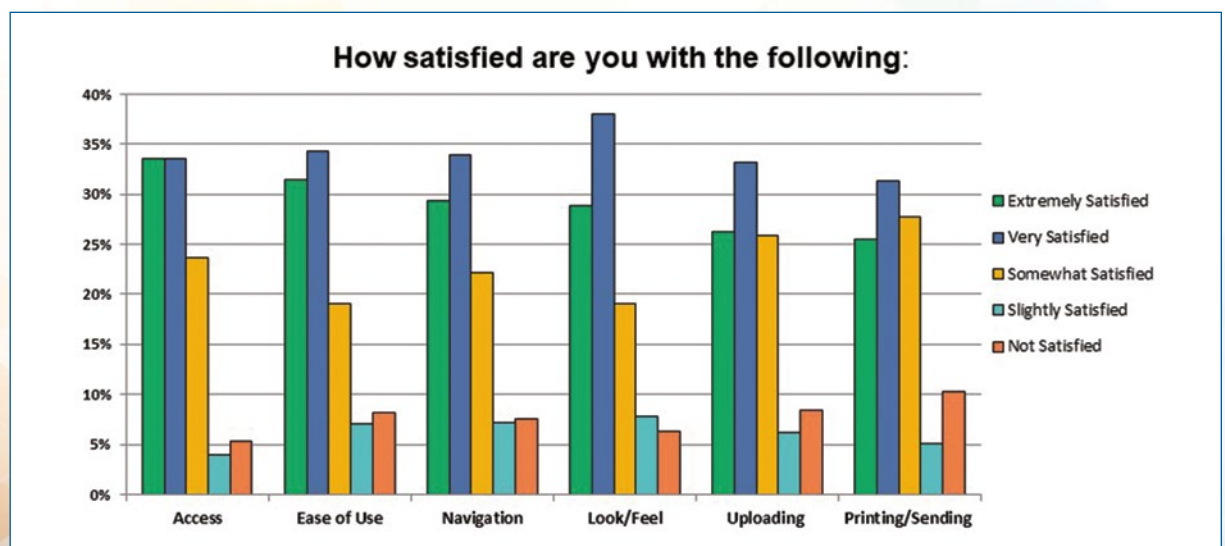
Available via the CPE Monitor Plus mobile app or web browser, My CPD allows pharmacists to create, record, and maintain their professional development. Learners can build and evaluate personal development plans, document learning activities, and upload supporting evidence of learning as well as its impact in practice. My CPD accounts for accredited CE as well other CPD activities undertaken in areas relevant to professional responsibilities.

ACPE surveyed earlier users of My CPD between November 19 and December 20, 2019 to obtain feedback on accessibility, functionality, frequency of use, and desired improvements to the platform. Just over 280 respondents completed the survey with 12 percent reporting they had never used My CPD. The majority of respondents indicated using the platform monthly to every two to three months (60 percent), and that fulfilling regulatory requirements was the primary reason for use (63 percent). Other reasons for use included fulfilling credentialing requirements (11 percent), documenting non-CE activities (9 percent), aiding in career development (5 percent), and fulfilling employment obligations (3 percent).

My CPD Survey Results (n=284)

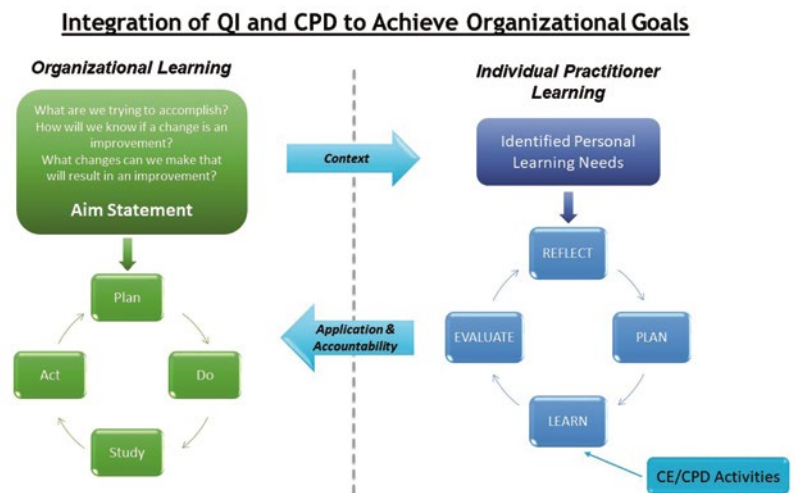

The majority of users (56 percent) indicated the platform did very to extremely well in meeting professional development needs. While more than 60 percent of respondents also reported being very to extremely satisfied with accessibility, ease of use, navigation, and platform look/feel, users were somewhat less satisfied with ability to upload documents and export CPD cycles.

As a lifelong learning approach and support tool, ACPE intends to enhance My CPD to address learner reflection functionality, reporting capabilities, and availability of CE resources based on professional competencies. Pilot Project of CPD to Strengthen Practice Development

A national collaborative led by the Alliance for Integrated Medication Management engages organizations in quality improvement initiatives that produce systems change for improved medication use. With support of University of Minnesota College of Pharmacy and ACPE, the alliance extended this model to include explicit attention to participants' self-directed lifelong learning in the context of defined performance improvement goals. Using a coaching model, participants engaged in the collaborative are applying the principles of CPD to their own learning and development to enhance success of healthcare teams in meeting their identified performance improvement goals. Starting in fall 2019, team members electing to participate in the CPD track are completing CPD cycles in My CPD while engaging in quarterly coaching calls. Upon completing the collaborative, participants will share key takeaways of their CPD journey. ■



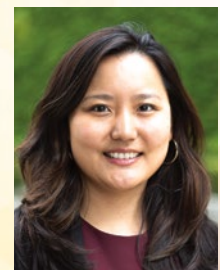
ACPE CPD New Commission Members

SMART Pharmacist Program



The SMART Pharmacist Program continues to grow and achieve great results while working to demonstrate the impact that better models of continuing education and continuing professional development can have on pharmacists' competencies, quality of pharmacy practice, and patient outcomes. New training workshops were held in Estonia, Montenegro, Oman, Qatar, and Serbia, including new clinical modules and train-the-trainer activities. The first results from data collected show a visible impact on patient care in the areas of diabetes, asthma, adherence, and other drug-related problems. The SMART Pharmacist Program was recognized and promoted at the FIP Regional Conference in October 2019 in Ankara, Turkey as the successful initiative that led to the collaboration of the Turkish Pharmacists Association with the World Health Organization in the area of cardiovascular diseases. ■
